# 3. Chair's report - Be Kind campaign (Kirsten Holmes)

CAUTHE is increasingly concerned about the impact of a culture of negative feedback and reviews. The culture of negativity impacts both individual academics careers and mental health, as well as the collectively on rankings and research income for Tourism, Hospitality and Events across both Australia and New Zealand. We call on colleagues to 'be kind' and reflect on how they provide feedback and assessments both face to face and anonymously. Our campaign is about increasing kindness and compassion towards each other while not reducing the rigour of our assessment of research. # • The Online 2021 conference

Unfortunately due to COVID-19, the original CAUTHE 2021 Conference, hosted by Curtin University, Edith Cowan University and Murdoch University in Fremantle has been rescheduled to 2022. But as part of our commitment to maintain a presence in the TH&E sector, CAUTHE 2021 is still going ahead. Paul Whitelaw will Chair the Conference committee and Marianna Sigala will Chair the Scientific Committee, CAUTHE 2021 conference will be held online over multiple day slots during the week commencing Monday 8 February and will be organised and managed by CAUTHE. The call for papers to be coming shortly.

There will need to be a small fee, with rates for members, students and non-members. The conference will incur significant costs, in purchasing a suitable event platform, and provide a rich conference experience. While CAUTHE is the local organising committee there will be liaison with the Chapter directors if there are any questions about governance.

# 12. Research | Advocacy | Supporting industry (Kirsten Holmes)

Chair's Advocacy report

Activities have included:

- Nomination for colleagues on the ARC College of Excellence. The current call includes Tourism in the list of FOR codes
- Submissions in support of the draft ANZSRC review recommendations to retain the 1506 FOR code
- Correspondence has been sent to State and Federal (AU/NZ) ministers offering the support of CAUTHE members' expertise in assisting the sector's response to COVID-19.
- It was suggested that the material from the submissions be used to write to the Vice-Chancellors.

Action: Chair to coordinate the circulation of material sent to State and Federal (AU/NZ) ministers to Vice-Chancellors.

# 13. Publishing in COVID-19 times Q&A (Marianna Sigala)

Perspective of Editor-in-Chief JHTM:

- Since March there have been increased submissions, including those related to COVID-19. However, quality decreased.
- Publishers are concerned about medium to long-term impact on publications. Impact on primary data collection.
- Seeking ideas to help CAUTHE and the Journal.

# 14. Iso-CHATS (Anne Hardy)

There has been a strong appetite for connection at the ISO-Chats, with 40-50 people regularly attending from AU, NZ and Asia and North America. It has become an important meeting point for tourism academics. This may be another avenue to showcase CAUTHE.

# 15. Academic Integrity: outcomes / strategies from an external institutional benchmarking project (Sharon Hebdon)

Background: HERDSA Small Provider Network project, 8 institutions participated from Victoria, Tasmania, NSW.

Purpose: Practices, level of effectiveness, measures/evidence.

Process: A detailed questionnaire included policy, breach, mitigating risks (students) and mitigating risks (staff). Findings included:

- Significant variation between institutions in terms of staff training and support
- Majority institutions report strong culture of supporting Academic Integrity
- Majority of institutions report staff see process as burdensome
- Use of text-matching software is not mandatory
- Majority of institutions reported need for greater consideration of non-text assessment

# 16. BREAKOUT ROOMS - Teaching during COVID & online assessment (Karen Smith)

Building on the Be Kind campaign participants were asked to "be kind" to themselves and identify something that has worked for them or their colleagues. While still sharing the challenges, pressures and things that haven't worked, participants were encouraged to draw out something (anything!) that can be constructively learned and shared with our membership.

# **Report back**

Team 1

- Speed of changes and lack of time to reflect on impacts
- Anxiety (students and staff) which reduced over time
- Changing teaching strategy within a few days
- Take-home exam design is difficult
- Online invigilation
- UTAS increased student numbers by offering new courses

- Could cherry pick guest speakers from anywhere in the world.
- Attendances were high and international students were not afraid to speak (cameras off)
- Got to know students well
